- 1. Lessee shall pay a deposit of fifty percent of the total rent upon signing the contract. The balance is due by October 1st. Space rented after October 1st shall be paid in full at the time of signing of the contract.
2. All exhibits must be in place not later than 5:00 P.M. opening day. Space not occupied will revert to the Fair, and all payment forfeited.
3. Exhibits and goods must be unpacked immediately upon arrival and empty cases removed, by and at the expense of exhibitors and concessionaires, who shall pay expense of conveying, delivering, arranging and removing their exhibits.
4. Deliveries by truck may be made on the grounds before operating hours of the Fair. No C.O.D. charges will be accepted by the Fair.
5. No electrical wiring is to be done on the Fair grounds by any exhibitor or concessionaire without the permission of the Fair management and under the supervision of the electrician appointed by the Fair.
6. Access to 1 duplex 110 volt single phase electrical outlet will be provided by the Fair to each exhibitor or concessionaire for each ten (10) front feet of space. Only common overhead lighting will be furnished by the Fair. Any extra lighting or electrical connections will be at the expense of the exhibitor or concessionaire. Additional outlets \$ _____
7. Exhibits must remain intact until 6:00 P.M. closing night. (THIS RULE WILL BE ENFORCED.)
8. Aisles must be kept clear. No signs, banners, advertising matter, decorations or parts of exhibits will be permitted in the aisles.
9. All decorations must be fireproof and subject to the approval of the Gainesville Fire Department.
10. All exhibitors and concessionaires are subject to all Federal, State, County and City laws governing taxes, health and safety of persons and/or property. No smoking in Exhibition Building at any time.
11. Machinery in motion must be enclosed with railing at a uniform height from ground or floor of two feet, six inches. Said railing to be placed upon or within the boundary of space occupied by exhibitor.
12. In case any exhibitor or concessionaire shall at any time be indebted to the Alachua County Fair, Inc., the corporation shall have the right to retain possession of all property of any exhibitor or exhibitors or concessionaires located at the Fair and shall sell and dispose of, either at public or private sale, all or any part thereof that may be necessary to pay the indebtedness due the corporation.
13. No claim for injury to any person for injury to, or loss of, any property on account of fire or theft, or for any other cause, shall ever be instituted against the Alachua County Fair, Inc., its officers or agents, by or on behalf of any person, firm or corporation having license or privilege to exhibit outside or in the buildings.
14. The exhibitor or concessionaire will not be permitted to sublet any part of the space herein leased, or to exhibit therein any article other than those manufactured or sold by himself and specified in this contract.
15. I understand that this contract does not give me any exclusive rights on my product.
16. Lessee's Insurance Statement; I carry liability insurance policy with _____ Insurance Company. A Certificate of Insurance must be furnished prior to opening day.
17. This contract entitles lessee to 4 exhibitor passes. Additional exhibitor passes will be available for the duration of the Fair at \$5.00 each. These passes are not transferable and must be forfeited if misused. No passes will be mailed, but may be picked up at the Fair office.
18. N.S.F. or returned checks will be charged \$28.00 per check.

The exhibitor is bound and agrees to abide by the rules and regulations as stated in this contract and any additional rules of the Fair Association.
