1. Exhibitor/concessionaire shall pay a deposit of fifty percent of the total rent upon signing the contract. The balance is due by October 1st. Checks will not be accepted after that date. Space rental after October 1st shall be paid in full at the time of signing the contract. N.S.F. or returned checks will be charged \$28.00 per check.
2. All exhibitors must be in place not later than 5:00 P.M. opening day. Space not occupied will revert to the Fair and all payment forfeited.
3. Exhibits and goods must be unpacked immediately upon arrival and empty cases removed by and at the expense of exhibitors and concessionaires, who shall pay expense of conveying, delivering, arranging and removing their exhibits.
4. Deliveries by truck may be made on the grounds before operating hours of the Fair. No C.O.D. charges will be accepted by the Fair.
5. No electrical wiring is to be done on the Fairgrounds by a concessionaire or exhibitor without the permission of the Fair management and under the supervision of the electrician appointed by the Fair.
6. Access to one duplex 110 volt single phase electrical outlet will be provided by the Fair to each exhibitor or concessionaire. Any extra lighting or electrical connections will be at the expense of the concessionaire or exhibitor and collected at the time of check-in. Fees for additional electrical service will be charged according to the Fair's rate schedule.
7. Exhibits and concessions must be manned at all times and remain intact until 7 P.M. closing night. **THIS RULE WILL BE ENFORCED.**
8. All tents and canopies must be fireproof and subject to the approval of the Gainesville Fire Department. A certificate must be readily available if requested by the Fire department.
9. All exhibitors and concessionaires are subject to all Federal, State County and City laws governing taxes, health and safety of persons and or property.
10. In case any exhibitor or concessionaire shall at any time be indebted to the Alachua County Fair, Inc., the corporation shall have the right to retain possession of all property of any exhibitor or concessionaire located at the Fair and shall sell and dispose of either at public or private sale, all or any part thereof that may be necessary to pay the indebtedness due the corporation.
11. No claim for injury to any person for injury to, or loss of any property on account of fire or theft or for any other cause, shall ever be instituted against the Alachua County Fair, Inc., its officers or agents, by or on behalf of any person, firm or corporation having license or privilege to exhibit outside or in the buildings.
12. The exhibitor or concessionaire will not be permitted to sublet any part of the space or to exhibit therein any article other than those manufactured or sold by himself and specified in this contract. In the event the exhibitor/concessionaire displays or sells any item not approved by the Fair Association, the Association could exercise the right to remove them from the premises.
13. Exhibitor/Concessionaire Insurance Statement; I carry liability insurance policy with _____ Insurance Company. A certificate of Insurance must be furnished prior to opening day.
14. I understand that this contract does not give me any exclusive rights on my product.

The exhibitor/concessionaire is bound and agrees to abide by the rules and regulations as stated in this contract and any additional rules of the Fair Association.
